If Insurance plan is **red font**, then we do not accept this insurance; and we will not bill the insurance either. You must pay 100% of the service charges.

**We also recommend that you call your insurance plan and ask them specifically about your Mental Health Benefits:**

- Who handles the claims as sometimes insurance companies will outsource mental health benefits to a 3rd party payer and we may not be in-network with that payer.
- Ask if your insurance plan requires your PCP to refer to one of our clinicians? If yes, then contact your PCP to initiate the referral as required by your insurance plan provisions.
- Ask if any authorization is required for Outpatient mental health services? If yes, then ask them for the authorization and provide our office with this information.
- Ask for your copay, coinsurance and deductible amounts for outpatient mental health services. These may be different than your regular medical amounts.

**Notices:**

- Your insurance plan is a contract between you and them. If we have submitted the claim and they do not cover the service, then you will be responsible for paying out-of-pocket for the services rendered. If you feel that your insurance should have paid on the claim, then it is your responsibility to contact them directly to have the claim re-processed.
- **HUMANA** insurance tends to outsource their mental health benefit to a 3rd party payer called **PsychCare**. We are not in-network with **PsychCare provider network through Beacon Health Options**. If you have **HUMANA** insurance, we will collect full fee for services at our self pay rate. You can try to submit a claim to your Humana plan for reimbursement.
- **Beacon Health Options** has two different provider networks—one for commercial plans and one for Medicare plans. It is very important that you check with your specific insurance plan and see if any of our providers at Cornerstone are listed in the network. We definitely do not accept Beacon Health Options with the insurance plans: AvMed, Aetna Medicare HMO (effective 1/1/2017), Freedom Health, Humana, Humana Medicare and PsychCare).
- **Gerald Horton, LCSW** Please call your insurance company to see if you need pre-cert or referral for seeing Gerald Horton, LCSW. Please let your insurance company know the initial visit with Mr. Horton is billed as cpt code 90791. The follow-up psychotherapy visits are usually cpt code 90837 or 90834.

**SPECIAL EMPLOYER PLANS:** If your company is listed below, please see the information about your mental health coverage.

- **HCA Hospital:** Your insurance is United Healthcare, but for your mental health coverage, this benefit and claims are handled by **Beacon Health**. Please refer to the Beacon Health insurance details above.
- **Comcast:** Your mental health benefit and claims is handled by **CompPsych**. Only Dr. Donahue is in-network with CompPsych insurance. You, the patient, must contact CompPsych to get a pre-authorization to see Dr. Donahue for your outpatient mental health visits. This must be done before your first visit.
- **LOWES:** Your insurance is United Healthcare, but for your mental health coverage, this benefit and claims are handled by **Magellan Health**. Please refer to Magellan Health for details.
- **State of Illinois:** Your insurance is Aetna, but for your mental health coverage, this benefit and claims are handled by **Magellan Health**. Please refer to Magellan Health for details.
